FELONY INDICTMENT

The Grand Jurors of Mohave County, Arizona, accuse **JUSTIN JAMES RECTOR**, charging that in Mohave County, Arizona:

COUNT 1: FIRST DEGREE MURDER, CLASS 1 FELONY

On or about the 2nd day of September, 2014, in the vicinity of 2436 Lakeside and the coordinates N35 05.280 W114 36.170, Bullhead City, Mohave County, Arizona, said Defendant, JUSTIN JAMES RECTOR, committed murder in the first degree of I.G.-C., all in violation of A.R.S. §§ 13-1105, 13-1101, 13-701, 13-702, 13-751, 13-704, 13-705, 13-118, and 13-801, a Class 1 Felony.

Specifically: The First Degree Murder, as charged in Count 1 of the Indictment in the above-entitled and numbered cause, was committed by JUSTIN JAMES RECTOR, who, intending or knowing that his conduct would cause death, with premeditation, caused the death of I.G.-C.; or,

alternatively, JUSTIN JAMES RECTOR committed or attempted to commit Kidnapping, A.R.S. §13-1304, or alternatively Child Abuse, A.R.S. §13-3623(A), and in the course of and in furtherance of such offense or offenses, or immediate flight from such offense or offenses, he caused the death of I.G.-C., all in violation of A.R.S. §§ 13-1105, 13-1101, 13-701, 13-702, 13-751, 13-704, 13-705, 13-118, and 13-801, a Class 1 Felony.

COUNT 3: CHILD ABUSE, CLASS 2 FELONY
A DANGEROUS CRIME AGAINST CHILDREN

On or about the 2nd day of September, 2014, in the vicinity of 2436 Lakeside and the coordinates N35 05.280 W114 36.170, Bullhead City, Mohave County, Arizona, said Defendant, JUSTIN JAMES RECTOR, committed child abuse by intentionally or knowingly causing physical injury to I.G.-C., a child less than fifteen years of age, under circumstances likely to produce death or serious physical injury, to wit: JUSTIN JAMES RECTOR strangled I.G.-C., all in violation of A.R.S. §§ 13-3623(A), 13-705, 13-701, 13-702 and 13-801, a Class 2 Felony.

On or about the 2nd day of September, 2014, in the vicinity of the coordinates N35 05.280 W114 36.170, Bullhead City, Mohave County, Arizona, said Defendant, JUSTIN JAMES RECTOR, knowingly moved a dead human body or parts of a human body with the intent to abandon or conceal the body or parts, all in violation of A.R.S. §§ 13-2926, 13-701, 13-702 and 13-801, a Class 5 Felony.
