**MOTION AND ORDERS  
FOR MENTAL HEALTH RECORDS**

14 The State of Arizona, by the Mohave County Attorney, and through the  
15 undersigned Deputy County Attorney, moves this Court for orders to disclose defendant's  
16 prior mental health records to the Mohave County Attorney.

17 Dr. Ernest Harman was nominated, by the State, to examine defendant's sanity at  
18 the time of defendant committed the offense as required by A.R.S. § 13-754. His  
19 appointment has yet to be confirmed by the court. Dr. Ernest Harman requested  
20 defendants prior mental health records in order to fully evaluate defendant's mental  
21 health.

22 Dr. Harvancik's Rule 11 report identified three facilities that may possess  
23 defendant's prior mental health records. Those facilities are: 1) Mohave Mental Health  
24 (records were transferred to the Kingman Office in 2014), 2) Mohave County Juvenile  
25 Detention Center, and 3) Adobe Mountain, Eagle Point. Adobe Mountain, Eagle Point  
reported to undersigned prosecutor that defendant's records were purged due to his



1 current age. The State has attached two orders—ordering mental health records for  
2 defendant from Mohave Mental Health and the Mohave County Juvenile Detention  
3 Center.
