14 COMES NOW, the State of Arizona, by the Mohave County Attorney and through  
15 the undersigned deputy, Gregory A. McPhillips, respectfully requests an expedited  
16 evidentiary hearing be set to rule on defendant's motion to allow defendant access to

18 Undersigned counsel recently learned, through correspondence, that the defense  
19 team intentionally did not provide State's disclosure to defendant because of this

expedited evidentiary hearing is needed to resolve this issue.


