Mr. Jolly informs the Court that he has been reviewing disclosure and believes that there is more disclosure from prior counsel that he has not received.

The Court is receptive of signing orders demanding previous defense counsel to provide all disclosure to current defense counsel.

IT IS ORDERED that the parties file a Joint Case Management Plan at least one week prior to the hearing just set.

As to CR-2017-01042:

Ms. Cassels requests that at this time the matter be continued to the same time as the Status Conference in the other matter. There are still outstanding public records requests and the Court signed the Order to Extend Time to Challenge the Grand Jury Proceedings; discussion ensues.

The Court finds that the State filed a Motion to Reconsider regarding the Motion to Extend Time to Challenge the Grand Jury Proceedings; the Court will not reconsider its ruling.
