25 **Tier 2 Case**

(Assigned to Hon. Lee Jantzen)

18 The parties agree that the dates listed in this Proposed Scheduling Order may need to be
19 modified based on the current situation caused by the Covid 19 virus.

20 **A. *Initial disclosure:*** The parties have already exchanged their initial 26.1 Disclosure
21 Statements.

22 **B. *Threshold issue Rule 19:*** The parties will simultaneously submit briefs on complying
23 with Rule 19 on October 20, 2021 by 5:00p.m. The parties estimate that it may take
24 approximately 120 days from the date of the Court order to comply with Rule 19.

3 **C. *Areas of expert testimony:*** The parties shall disclose areas of expert testimony by March
4 10, 2022.

5 **D. *Expert witnesses and their opinions:*** The parties shall identify and disclose expert
6 witnesses and their opinions by April 15, 2022. The parties shall disclose rebuttal expert opinions
7 by May 9, 2022.

8 **E. *Propounding written discovery:*** The parties shall propound written discovery by May 9,
9 2022.

10 **F. *Disclosing nonexpert witnesses:*** The parties shall disclose nonexpert witnesses by July
11 5, 2022.

12 **G. *Completing depositions:*** The parties shall complete all depositions by September 15,
13 2022.

14 **H. *Completing all discovery (other than depositions):*** The parties will respond to all
15 discovery undertaken pursuant to Rules 33 through 36 by November 8, 2022.

16 **I. *Final supplemental of Rule 26.2 disclosure:*** The parties shall provide final supplemental
17 disclosure by November 16, 2022. This order does not replace the parties' obligation to
18 seasonably disclose Rule 26.1 information on an on-going basis and as it become available.

19 **J. *Settlement conference or private mediation:*** The parties have agreed that a Settlement
20 Conference should be scheduled by June 6, 2022.

21 **K. *Dispositive motions:*** The parties shall file all dispositive motions by December 1, 2022.

22 **L. *Proposed Trial Date:*** The parties will be ready for trial by March 13, 2023, and request
23 that a trial setting conference be scheduled by the Court.
