The Court reviews the file; notes that the Plaintiff filed Motions on her own behalf prior to being self-represented; the Court held all motions filed by the Plaintiff in abeyance, including the Motion for Injunctive Relief filed October 24, 2022; the Court finds that Counsel Oehler did not receive a copy of the recently filed Motion; and advises that the Court will now address each motion.

**IT IS ORDERED** that all future Motions / Filings filed by the Plaintiff shall contain only one issue contained within the motion heading.
