Defendants, by and through undersigned counsel, hereby submit their Application for Attorney Fees and Costs pursuant to this Court's Order of December 21, 2023, as follows:

Defendants request that the Court award to Defendants from Plaintiff \$215,468.50 in reasonable fees plus \$1,786.00 taxable costs for a total request in the amount of \$217,254.50.

This Application is supported by the attached **Exhibit A** - Matter History Report for the time period February 2018 through December 2021, **Exhibit B** - Matter History Report for the time period January 2022 through November 2023, **Exhibit C** - Matter History Report for the time period December 2023, the Affidavit of Attorney Fees and the Statement of Costs filed by Daniel J. Oehler on a date even herewith, and this Court's entire verified file in this matter. Under the provisions of the Fee Agreement for Legal Services, the Defendants, GLEN LUDWIG and PEARL LUDWIG, Trustees of THE LUDWIG FAMILY TRUST, FAIRWAY CONSTRUCTORS, INC., and MEHDI AZARMI, and the Law Offices

of Daniel J. Oehler agreed to an hourly billing rate of \$325.00 per hour to be charged for legal services rendered, and the Law Offices of Daniel J. Oehler has been consistently paid by the Defendants, excepting only the fees and costs incurred for the current month of December 2023 which have not yet been billed.

It should be noted the amounts requested in this Application do not include the fees and costs previously awarded to Defendants and against Plaintiff pursuant to the Judgment for Attorney's Fees and Costs entered by this Court on October 17, 2023, in the total amount of \$6,320.69 (fees \$6,230.25 and costs \$90.44). **Exhibits A, B and C** attached hereto incorporate all fees and costs, including those previously awarded to Defendants against the Plaintiff on October 17, 2023 in the amount of \$6,320.69.
